

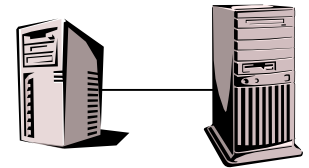


LiquioCompliance™

LiquioCompliance™ is the industry's first multi-enterprise solution for Compliance Labeling and EDI designed to make 100% Label and EDI Compliance achievable for both customers (LiquioCustomer™) and suppliers (LiquioVendor™). LiquioCompliance™ uses thin-client barcode labeling technology and an Application Service Provider (ASP) service model to provide a robust, immediate and affordable collaborative solution for Compliance Labeling and EDI.

The Data Center

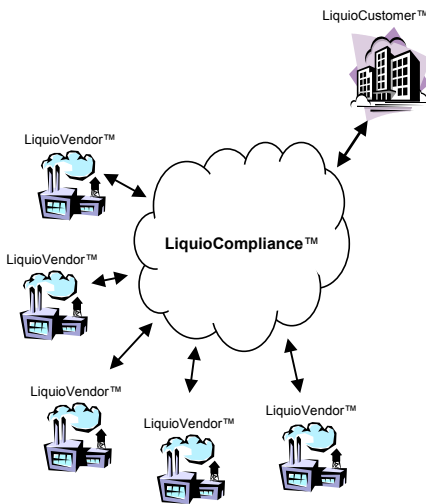
The foundation for LiquioCompliance™ is a clustered bank of labeling servers located in Liquio's secure data center. These servers contain all the application logic necessary for the Labeling and EDI processes. The data center is the single point of contact for all LiquioCustomers™ and LiquioVendors™ for maintenance of Labeling and EDI compliance standards. The servers synchronize and coordinate all LiquioCustomer™ and LiquioVendor™ business data and EDI transactions [e.g. purchase order, line item, product detail, invoicing].



LiquioCustomer™

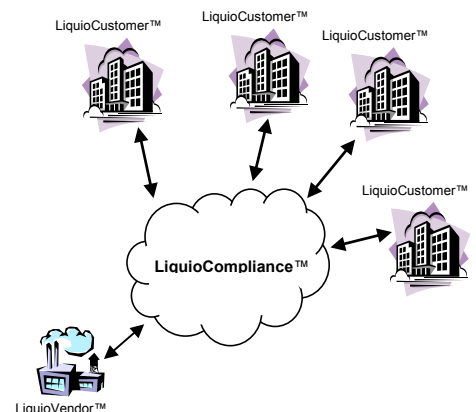
LiquioCompliance™ provides customers the ability to immediately achieve 100% Labeling and EDI vendor compliance without significant capital expenditure, system integration or vendor solution certification. Liquio works closely with the LiquioCustomer™ to develop, implement and certify the label designs and EDI requirements for the LiquioVendor's™ use. For the LiquioCustomer™, LiquioCompliance™ provides a single point of contact to send all vendors EDI Purchase Orders and to receive vendor EDI Advance Shipment Notifications. Changes, including new Label and EDI specifications, are immediately and transparently available to all LiquioVendors™. This makes implementation of additional features and industry best-practices such as serialization, lot control and 2D barcode symbologies easy to include in supply-chain initiatives.

For LiquioCustomers™ with existing Label and EDI Compliance programs, LiquioCompliance™ provides a way to immediately address all remaining non-compliant vendors – making 100% compliance rapidly achievable.



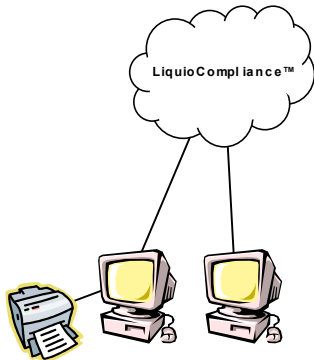
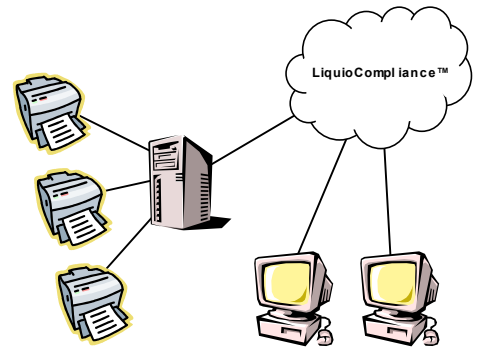
LiquioVendor™

LiquioCompliance™ provides vendors the ability to immediately achieve 100% Labeling and EDI Compliance without any capital expenditure, system integration, software development, EDI integration or label design. For the LiquioVendor™, LiquioCompliance™ provides a single certified solution to comply with all its customers' Labeling and EDI requirements. New Label requirements and EDI specifications are immediately and transparently available. The LiquioVendor™ requires no infrastructure to use the system. The monthly subscription includes computer, printers and supplies; the LiquioVendor™ is responsible for local Internet access. Technical support which includes upgrades, help desk and hardware maintenance is standard.



Print Stations

LiquioCompliance™ supports two basic types of print stations: a dedicated network print controller managing multiple printers in a location; or a workstation print controller managing one or two local printers. An advantage of the network controller architecture is the ability to print from all workstations, even those without a locally attached printer. Workstation support includes Windows NT, Windows 2000, Windows XP, Solaris and Linux. The two controller architectures enable LiquioCompliance™ to support enterprises of all sizes, from very large to very small. All print controllers support any major brand of thermal or laser printer.



Workstations

LiquioCompliance™ provides all the system functionality to manage the labeling business process and administer the ASP solution. Standard functionality includes administration, security and workflow management. Custom integration into business or accounting systems is available as necessary. The user-based administration tools allow the administrator to grant front office users [order entry, logistics, distribution, shipping] access to just the functionality [scheduling, release, data collection] they require. Rollout, administration and maintenance of LiquioCompliance™ is easy. Thin-client ASP architecture allows the administrator to give users access or upgrades remotely without any local software installation. LiquioCompliance™ users only require a standard browser [Netscape Navigator or Microsoft Internet Explorer].

Order-Based Workflow Support

In addition to Item, Master and Pallet Labeling, LiquioCompliance™ supports an adaptable order-based workflow for both EDI and Labeling. From acceptance, review and release of purchase orders, to labeling and shipping of physical product, the LiquioVendor™ can choose, configure and customize the appropriate workflow for its particular business processes.
